TURFWAY PARK RULES & CONDITIONS FOR RACING & TRAINING

PLEASE NOTE: The following agreement must be read and signed by both the trainer and the attending veterinarian and the signature portion returned to the CDI medical director (William.Farmer@kyderby.com) before the trainer will be permitted to enter horses. See page 7.

As a condition to, and in consideration for the undersigned trainer ("Trainer") being permitted to race, work, or train any horse at a Churchill Downs Incorporated ("CDI") owned facility, including, Churchill Downs Racetrack, Churchill Downs Training Center, Ellis Park or Turfway Park (each, a "Churchill Facility"; and collectively, the "Churchill Facilities"), the Trainer and the undersigned Trainer's attending veterinarian ("Attending Veterinarian") hereby agree to be bound by the following conditions (the "Conditions"):

1. At all times, a horse must be in serviceable, sound racing condition in order to stable, race, work or train at a Churchill Facility. In the event any horse under Trainer's care enters a CDI facility and is not registered with HISA (for any reason, including, without limitation, that the horse is not required to be registered under HISA's rules because it has not yet had its first official timed and reported work), Trainer shall promptly, but in all cases within twenty-four (24) hours of such horse entering a CDI Facility, voluntarily register any such horse with HISA. The Trainer acknowledges that it is his/her obligation to (a) confirm the horse is in serviceable and sound racing condition, in order to stable, race, work or train on a Churchill Facility's grounds and (b) to inform the CDI Equine Medical Director or his/her authorized designee of any changes in the horse's fitness or health that would prevent a horse from stabling, racing, working or training on a Churchill Facility's grounds or any changes which would put Trainer, the Attending Veterinarian, or any horse in violation of these Conditions. Any horse that has not raced within thirty (30) months since its last start shall be presumed unsound and ineligible to stable, race, work, or train at any Churchill Facility, unless approved in advance by the CDI Equine Medical Director or his/her authorized designee. Any horse six (6) years old or older that has never started shall be presumed unsound and ineligible to stable, race, work or train at any Churchill Facility unless approved in advance by the CDI Equine Medical Director or his/her authorized designee.

2. Trainer will not enter a horse in any race UNLESS the horse has: (a) been examined by Trainer's Attending Veterinarian during the three (3) days immediately preceding the close of entries for the selected race for the express purpose of evaluating the horse's fitness to race; and (b) been found fit to race by the Attending Veterinarian. This evaluation shall include, at a minimum, watching the horse jog and any other requirements set under any law, regulation, or house rule. The Attending Veterinarian and Trainer are each obligated to inform the CDI Equine Medical Director and the Kentucky Horse Racing Commission ("KHRC") official veterinarian or his/her designee of any changes in the horse's fitness after entry at any time prior to the race. The Racing Secretary, in consultation with the CDI Equine Medical Director or his/her authorized designee(s), may, but shall not be obligated to, consider any extenuating circumstances to the examination requirement of this rule on a case-by-case basis.

3. Trainer will not permit a horse stabled at or shipped in to a Churchill Facility to work UNLESS the horse has: (a) been examined by the Trainer's Attending Veterinarian during the five (5) days immediately preceding the work for the express purpose of evaluating the horse's fitness to work; and (b) been found fit to work by the Attending Veterinarian (this evaluation shall include, at a minimum, watching the horse jog and any other requirements set under any law, regulations, or house rule). The Attending Veterinarian and Trainer are obligated to inform the CDI Equine Medical Director or his/her designee of any changes in the horse's fitness at any time after the examination set forth above and before the horse works.
4. Trainer will not permit a horse placed on the Veterinarian's List to perform any high-speed (published) work for seven (7) days following placement on the Veterinarian's List.
5. Trainer will not enter in any race a horse that is a four-year old or older first time starter or a previously raced horse that has not raced in the 365 days preceding the date of the selected race UNLESS, in addition to the criteria set forth in Section 2 above and any other criteria set forth in any law, regulation, or house rule, such horse has completed an official work for the KHRC veterinarian or his/her designee prior to entry. The CDI Equine Medical Director may require evaluation(s) of any horse that has not raced within the one hundred fifty (150) days but have raced within the three hundred sixty-five (365) days preceding the date of the selected race. Based upon such evaluation, the CDI Equine Medical Director may (in his/her sole discretion) impose and require the horse to meet any additional requirements prior to being able to enter. Based upon that examination, the CDI Equine Medical Director may require the horse to work prior to being allowed to enter. If the horse is required to work under this provision, it must meet the same requirements as a horse that is working off of the KHRC's Veterinarian's list.
6. Trainer will not enter in a race: (a) any horse that has finished twelve (12) or more lengths behind the winner in each of its last five (5) starts, or (b) any horse that has raced greater than four (4) times in the fifty-six (56) days immediately preceding the race date.
7. Under no circumstances shall an examination conducted by a veterinarian who has NOT been identified as the Trainer's Attending Veterinarian under these Conditions constitute a valid examination for purposes of determining a horse's fitness to race, work or train.
8. The Churchill Facilities and the CDI Equine Medical Director or his/her authorized designee(s) are entitled (but not obligated) to contact, without prior notice, Trainer's Attending Veterinarian to confirm that examinations have been conducted pursuant to these Conditions and that any such examination meets the applicable Churchill Facility's requirements. The Churchill Facilities and the CDI Equine Medical Director shall have the right (but not the obligation) to examine and review all records of examinations performed in accordance with these Conditions, and Trainer agrees that the applicable Churchill Facility or the CDI Equine Medical Director may inspect and copy for each's own use, and Trainer shall provide upon request, all documents, electronic or otherwise, containing reports by official racing veterinarians of pre-race examinations, post-race examinations (including without limitation necropsy reports) and/or any records of procedures required by regulatory agencies or under applicable industry safety accreditation organizations of Trainer's horse(s) racing or training at each Churchill Facility.

9. All horses stabled or entered to race at a Churchill Facility, or present on a Churchill Facility's grounds, are subject to: (a) veterinary inspections and requests for veterinary medical records by the CDI Equine Medical Director, or his/her designee and (b) veterinary monitoring. Trainer, Trainer's staff, and Attending Veterinarians will cooperate fully with all requests made by CDI veterinarians and the applicable Churchill Facility's staff.

10. As used herein, the term "Attending Veterinarian" shall include the undersigned veterinarian and any veterinarian who is a member of his/her veterinary practice.

11. If stabled on a Churchill Facility's grounds, both Trainer and the Attending Veterinarian will abide by all rules and regulations of the applicable Churchill Facility, including, without limitation, House Rules (including those relating to equine welfare and integrity), or other rules (including, without limitation, all rules set forth in the applicable Churchill Facility's Condition Book, Stall Application, the Rules of the Barn Area, and the Rules of the Track), all of which are hereby expressly incorporated by reference herein. Trainer and Attending Veterinarian shall be responsible for obtaining and becoming familiar with such rules and regulations.

12. All KHRC licensees, including but not limited to each Churchill Facility, owners, trainers, jockeys, and grooms ("licensees"), participating in stabling, racing, training, and related activities at the Churchill Facilities recognize that hazards and risks inherent in such activities may cause the injury or death of horses. Therefore, in consideration of participating in stabling, racing, training, and related activities at a Churchill Facility, all licensees assume the risks of, and release, hold harmless and covenant not to sue all other licensees so participating for: (i) Ordinary negligence which causes or contributes to loss, loss of use, injury or damage to horses while on the premises of such Churchill Facility; and (ii) Ordinary negligence which causes or contributes to personal injury or property damage, including but not limited to loss, loss of use, injury or damage to horses arising from the use of grass fields or gallops owned or controlled by such Churchill Facility, whether arising from alleged acts or omissions of a licensee and its agents or employees, the condition of the premises of such Churchill Facility or any other cause. Except as provided above, all licensees participating in racing, training, and related activities at a Churchill Facility shall be responsible for their own acts and omissions and those of their agents and employees to the same extent as provided by law. The foregoing provisions shall be construed in a manner consistent with the limitations set forth herein to be as broad and inclusive as permitted by the laws of the Commonwealth of Kentucky and the KHRC's regulations and shall be binding upon Trainer, its successors and/or assignees. The maintenance by CDI or any of its subsidiaries of insurance shall not affect the terms or interpretation of this Agreement. The foregoing release shall extend to CDI's and its subsidiaries' officers, directors, agents, employees, contractors, servants and licensees. In the event of any inconsistency between these provisions and the KHRC's regulations, the KHRC's regulations shall control. Further, these provisions shall be deemed to be amended to the extent of, and to be in compliance with, any amendment to the KHRC's regulations.

13. Both Trainer and Attending Veterinarian will abide by all rules and regulations of the KHRC and the Horseracing Integrity and Safety Authority (“HISA”), at any time expressly incorporated by reference herein, and the rules and regulations of the KHRC or HISA, at any time adopted or as they may be amended. Trainer and Attending Veterinarian shall be responsible for obtaining and becoming familiar with such rules and regulations. Ignorance of such rules and regulations shall not be considered a defense for non-compliance therewith.

14. Any failure by CDI or a Churchill Facility to enforce any terms or conditions of this Agreement shall not constitute a waiver by such Churchill Facility, and shall not affect or impair this Agreement in any way, or the right of CDI at any time to enforce this Agreement. A Churchill Facility representative’s approval or consent to any action proposed by Trainer or Attending Veterinarian shall not (a) waive Trainer or Attending Veterinarian’s obligation to strictly comply with this Agreement, or (b) be construed as an undertaking of Churchill Facility, the CDI Equine Medical Director, or any other designee or either such party to treat, diagnose, or otherwise be responsible for the condition of any horse.

15. Both Trainer and the Attending Veterinarian understand and acknowledge that these Conditions shall be in effect annually commencing on the date of the opening of the Churchill Downs Racetrack stable area prior to the Churchill Downs Racetrack Spring Meet (or any successor meet therefor) each year and continuing through the conclusion of the Turfway Park Winter/Spring Meet (or any successor meet therefor) the following year, and for Trainers that have horse(s) on a Churchill Facility’s grounds, these Conditions shall be in effect from earliest date noted below and for so long as Trainer has horse(s) on such Churchill Facility’s grounds.

By signing below, Trainer acknowledges and agrees that Trainer (a) has read and fully understands the Conditions and agrees to be bound by them, (b) will consult with Trainer’s Attending Veterinarian and the CDI Equine Medical Director if Trainer has any questions regarding such Conditions, and (c) will fully comply with the Conditions.

By signing below, the Attending Veterinarian acknowledges and agrees that he/she (a) is the Attending Veterinarian for the undersigned Trainer, (b) has read and fully understands the above Conditions and agrees to be bound by them, (c) will consult with the CDI Equine Medical Director if he/she has any questions regarding such Conditions, and (d) will comply fully with the Conditions.

Any change in the party that will be acting as the Trainer’s Attending Veterinarian requires Trainer and the new Attending Veterinarian to submit a fully executed copy of these Conditions to CDI Equine Medical Director.

EQUINE SAFETY INITIATIVES

Several equine safety initiatives have been implemented at Turfway Park. Below are the changes and how they affect you.

1. RULES AND CONDITIONS FOR RACING AND TRAINING AGREEMENT: This must be signed and submitted to the Stable Office upon arrival. This agreement will cover all Kentucky CDI properties and will be in effect until the end of the Turfway Park 2025 Winter-Spring Meet. Please make sure you and your veterinarian sign prior to turning it in.

2. REGISTRATION WITH HISA: All horses (except for stable ponies) must be registered with HISA upon entry into any CDI facility, regardless of their Covered Status due to their first official and timed workout.

3. WORKING AFTER PLACEMENT ON VETERINARIAN'S LIST: Trainer will not permit a horse placed on the Veterinarian's List to perform a high-speed (published) work for seven (7) days following placement on the Veterinarian's List.

4. MEDICATION-RESTRICTED RACES: Pursuant to HISA regulations, all two (2) year-old races and stakes races will be conducted Lasix-free. Please consult with your veterinarian, Churchill Downs Equine Medical Director (Dr. Farmer), or the KHRGC if you have any questions regarding this regulation.

5. SHOCKWAVE THERAPY TREATMENTS: All prescribed shockwave treatments require a 48-hour notice and shall be witnessed by a TP Security Officer. Please contact Dr. Farmer to schedule. FOLLOWING A SHOCKWAVE TREATMENT ALL HORSES ARE INELIGIBLE TO HAVE A HIGH-SPEED WORK FOR 14 DAYS OR A RACE FOR 30 DAYS. Trainers and Veterinarians violating this rule are subject to HISA penalties along with revocation of stalling privileges at CDI properties.

6. RE-ENTRY EXAM: Pursuant to KHRGC regulation, all horses must have an exam performed by your veterinarian within the three (3) days preceding a race entry. This exam is to be documented by your veterinarian and he/she will include their findings on their daily treatment records submitted to the KHRGC/HISA.

7. PRE-WORK EXAM: All horses stabled at Churchill Downs, Ellis Park, Trackside or Turfway Park must have an exam performed by your veterinarian within the five (5) days preceding a timed workout, per the Rules and Conditions for Racing and Training agreement. This exam is to be documented by your veterinarian and submitted to KHRGC/HISA.

8. ENTRY RESTRICTIONS:

A) Age Restrictions:

- 1) All 4-year old and older first time starters and any previously-raced horse that has not raced in the previous 365 days must contact the KHRGC veterinarians to schedule an official veterinary work PRIOR to entry.
- 2) Any horse six (6) years or older that has never started is ineligible to stable, train or race at any Churchill Downs Property.

B) Lay-Offs:

1) Any horse that has not raced within one hundred fifty (150) days but has raced within three hundred sixty-five (365) days preceding the date of the selected race must have submitted a POST LAYOFF report per HISA rule 2142(a) PRIOR to being eligible to enter in a race.

2) Any previously raced horse that has not raced in the previous 30 months is ineligible to train or race at any Churchill Downs Property, unless approved in advance by the CD Equine Medical Director.

C) Poor Performance: Horses that are beaten by twelve (12) or more lengths in five consecutive starts will be ineligible to race at any Churchill Downs Property until approved by the Equine Medical Director to return.

D) Restricted Number of Starts: Horses will be limited to four starts in a rolling eight-week period (56 days).

9. **IN-TODAY SIGNAGE:** All horses entered to race must be clearly identified starting at 7:30 a.m. on race day with an "In-Today" sign. Trainers should hang these signs on the stall door or adjacent to the stall. This is separate from the KHRGC Lasix tag hung following Lasix administration. Extra signs are available in the Stable Office.

10. **INTRA-ARTICULAR INJECTIONS:** Horses that receive IA injections into the fetlock joint containing corticosteroids are prohibited from working for 14 days and racing for 30 days. All other IA injections have a 7-day stand-down for high-speed works and a 14-day stand-down for racing.

HORSERACING INTEGRITY AND SAFETY ACT (HISA)

Turfway Park encourages all horsemen to familiarize themselves with the Horseracing Integrity and Welfare Unit (HIWU) Anti-Doping and Medication Control (ADMC) guidelines that took effect May 22, 2023.

HISA COVERED HORSE REGISTRATION

All horses must be registered with HISA as a Covered Horse upon completion of their first timed and recorded workout.

SELECTED HISA RULES

HISA Rule 2263: Waiver Claiming Rule

. Waiver Claiming Option (a) At time of entry into a Claiming Race an Owner or Responsible Person may opt to declare a Covered Horse ineligible to be claimed, provided: (1) the Covered Horse has not started in 120 days; (2) the Covered Horse's last start must have been for a claiming price; and (3) the Covered Horse is entered in a claiming race with a claiming price equal to or greater than the claiming price for which it last started. (b) A Responsible Person may opt to declare a Covered Horse ineligible to be claimed for a second consecutive race, provided: (1) the waiver must have been asserted in the first race back to be eligible for the second waiver; (2) if the Covered Horse wins the first race back, it is ineligible for the second waiver; (3) if the Covered Horse changes majority ownership subsequent to the first race, it is ineligible for the second waiver; and (4) the provisions in 2263(a)(3) still apply.

Turfway Park, shall consider waiver claiming races the same as a starter allowance, in regard to eligibility and weight allowances / penalties.

HISA Rule 2143: Recording of Required Vaccines and Tests

As of January 1, 2023, HISA will start enforcing Rule 2143, preventing your horse from racing if the following vaccines and tests are (a) not listed on the Horse's Health records or (b) not up to date as required by HISA rule 2143. The required tests and vaccines are: Certificate of Veterinary Inspection (health certificate), Coggins Test, and Encephalitides, Rabies, Tetanus, Influenza and Rhinopneumonitis vaccines. HISA Rule 2276: Horseshoes

Partial HISA regulation; for full information see hisaus.org

Synthetic surface:

Front: 2 mm full outer rim, no grabs.

Hind: 2 mm full outer rim, no grabs.

Note: Queens XTs and similar shoes are NOT permitted on synthetic

HISA Rule 2293: Equipment

(a) Helmets:

(1) Any person mounted on a Horse or stable pony anywhere on racetrack grounds shall always wear a properly secured safety helmet.

(2) All starting gate personnel shall always wear a properly secured safety helmet while performing their duties or handling a Horse.

(3) The safety helmet may not be altered in any manner and the product marking shall not be removed or defaced.

(4) The stewards, or their designees, shall inspect safety helmets at the beginning of a Race Meet and randomly throughout the Race Meet.

(5) The Clerk of Scales shall report to the stewards any variances of safety helmets seen during the course of their work.

(6) The helmet must comply with one of the following minimum safety standards or later revisions:

(i) American Society for Testing and Materials (ASTM 1163);

(ii) European Standards (EN-1384 or PAS-015 or VG1);

(iii) Australian/New Zealand Standards (AS/NZ 3838 or ARB HS 2012); or

(iv) Snell Equestrian Standard 2001.

(b) Vests:

- (1) Any person mounted on a Horse or stable pony on the racetrack grounds must wear a properly secured safety vest at all times.
- (2) All starting gate personnel must wear a properly secured safety vest at all times while performing their duties or handling a Horse.
- (3) The safety vest may not be altered in any manner and the product marking shall not be removed or defaced.
- (4) The stewards shall inspect safety vests at the beginning of a Race Meet and randomly throughout the Race Meet.
- (5) The clerk of scales shall report to the stewards any variances of safety vests seen during their course of work.
- (6) The safety vest must comply with one of the following minimum standards, as the same may be from time to time amended or revised:
 - (i) British Equestrian Trade Association (BETA):2000 Level 1;
 - (ii) Euro Norm (EN) 13158:2000 Level 1;
 - (iii) American Society for Testing and Materials (ASTM) F1781-08 or F1937;
 - (iv) Shoe and Allied Trade Research Association (SATRA) Jockey Vest Document M6-3; or
 - (v) Australian Racing Board (ARB) Standard 1.1998.

HISA Rule 2281: Riding Crop Specifications

- (a) Riding crops are subject to inspection by the Safety Officer, stewards, and the clerk of the scales.
- (b) All riding crops must be soft-padded.
- (c) Riding crops shall have a shaft and a smooth foam cylinder and must conform to the following dimensions and construction:
 - (1) The maximum allowable weight shall be eight (8) ounces;
 - (2) The maximum allowable length, including the smooth foam cylinder attachment, shall be thirty (30) inches;
 - (3) The minimum diameter of the shaft shall be three-eighths of one inch; and
 - (4) The shaft, beyond the grip, must be smooth, with no protrusions or raised surface, and covered by shock absorbing material that gives a compression factor of at least one millimeter throughout its circumference.
 - (5) There shall be no binding within seven (7) inches of the end of the shaft.

(6) The smooth foam cylinder is the only allowable attachment to the shaft and must meet the following specifications:

- (i) Shall have no reinforcements;
- (ii) Shall have a maximum length beyond the shaft of one inch;
- (iii) Shall have a minimum diameter of 0.8 inches and a maximum width of 1.6 inches;
- (iv) There shall be no other reinforcements or additions beyond the end of the shaft;
- (v) Shall be made of shock absorbing material with a compression factor of at least five millimeters throughout its circumference; Page 51 of 55
- (vi) Shall be made of a waterproof, ultraviolet, and chemical resistant foam material that is durable and preserves its shock absorption in use under all conditions; and
- (vii) Shall be replaced after reasonable wear and tear is visibly evident.

(7) Riding crops shall not be altered and shall have an appropriate label or marking designating that the riding crop meets the required standards as established by the Authority.

HISA Rule 2261: Transfer of Claimed Horse Records

(a) Entry of Horses subject to being claimed in a Claiming Race implies Owner (Trainer as the agent of the Owner) consent for transfer of all Trainer and veterinary examination and treatment records for the last sixty (60) days to the new Trainer of the claimed Horse.

(b) If a Horse is successfully claimed by a new Trainer, the previous Trainer must transfer Trainer records and authorize transfer of veterinary records to the new Trainer within three (3) days of transfer of the Horse to the new Trainer.

HORSES: 810 KAR 4:010

OWNERSHIP

The stewards may at any time require presentation of a horse's registration certificate, virtual certificate, or racing permit or other proof of ownership.

Upon claim, sale or any other transfer of ownership, the horse's registration certificate or racing permit shall be given to the new owner and any virtual certificate shall be transferred to the new owner electronically. The new owner shall report the change in ownership to the stewards.

THOROUGHBRED AGE RESTRICTIONS: SECTION 7

(2) A first-time starter five (5) years of age or older shall be approved by a commission veterinarian prior to entry.

FILLIES AND MARES BRED: SECTION 9

(3) A filly or mare in-foal shall not be entered in a race 120 days or more after the date of last cover.

SERVICEABLE FOR RACING: SECTION 10

A horse shall not be entered or raced that: (3) Has previously raced, but has made no starts in the last 365 days or more, unless approved by a commission veterinarian prior to entry

SEX ALTERATION: SECTION 12

Any alteration in the sex of a horse shall be reported by the horse's trainer to the racing secretary and to the breed registry. The alteration shall be noted on the horse's registration certificate, racing permit, virtual certificate, or entry in the electronic system.

ENTRIES, SUBSCRIPTIONS & DECLARATIONS: 810 KAR 4:030

WORKOUT RULE: SECTION 3

(8) (a) A horse that has not started in the past forty-five (45) days shall not be permitted to start unless it has at least one (1) published workout within twenty (20) days of entry at a distance satisfactory to the stewards. If a horse has performed the requisite workout, but the workout does not appear in the past performances, the horse shall be permitted to start if the stewards determine that the workout failed to be published through no fault of the trainer.

(b) A horse that has not started in the past ninety (90) days shall not be permitted to start unless it has at least two (2) published workouts during the past ninety (90) day period, one of which occurs within twenty (20) days of entry at a distance satisfactory to the stewards. If a horse has performed the requisite workouts, but the workouts do not appear in the past performances, the horse shall be permitted to start if the stewards determine that the workout failed to be published through no fault of the trainer.

(c) A horse that has not started in the past 180 days shall not be permitted to start unless it has at least three (3) published workouts during the past 180-day period, one (1) of which occurs within twenty (20) days of entry, at a distance satisfactory to the stewards. If a horse has performed the requisite workouts, but the workouts do not appear in the past performances, the horse shall be permitted to start if the stewards determine that the workouts failed to be published through no fault of the trainer.

(d) A horse starting for the first time shall not be permitted to start unless it has three (3) workouts, one (1) of which is from the starting gate, one (1) of which is within twenty (20) days of entry, and at least one (1) of which is published.

EXAMINATION BY ATTENDING VETERINARIAN: SECTION 17

(1) Subject to the exception in subsection (4), **a horse shall only be entered if: (a) The horse has been examined by an attending veterinarian licensed by the veterinary regulatory body in the jurisdiction where the examination occurs no more than three (3) days prior to entry; (b) The attending veterinarian certifies in writing that the horse is in serviceable, sound racing condition; and (c) The written certification is provided to the KHRC Veterinarians office no later than the time of entry.**

(2) The examination required by paragraph (a) of subsection (1) of this section shall include watching the horse jog in hand.

(3) If the attending veterinarian who examines the horse prescribes a diagnostic test as part of the evaluation of the horse's soundness, the results of the test shall be provided to the commission's veterinarian no later than one (1) day before the horse is set to start.

(4) If a racing secretary contacts a trainer to fill a race, the trainer may enter a horse prior to obtaining the examination and written certification required in this section, if the certification required in this section is provided to the KHRC Veterinarian's Office: (a) on the same day that the horse is entered; and (b) prior to the race in which the horse is entered.

EQUINE INJURY DATABASE

In consideration of the acceptance of a nomination of any horse to any race described in the condition book, the owner(s) and trainer of such horse consent to the collection of information related to any equine injury occurring at the Turfway Park facility to such horse and entry of said information into a database maintained by The Jockey Club (the "Equine Injury Database").

Said owner(s) and trainer further agree to indemnify, release, hold harmless and covenant not to sue Turfway Park LLC or its owners, any state or track appointed veterinarian collecting such information, and The Jockey Club (collectively, the "Indemnified Parties") from and against any liability, cost, loss, or expense of any kind or nature (including, without limitation, reasonable attorneys' fees) arising from any claim, demand, or action (a) alleging that the data entered into the Equine Injury Database (either directly or indirectly) violates the rights of the owner(s), trainer, or any third party, or (b) relating to any equine injury report run, published or otherwise created by any of the Indemnified Parties, including the owners, stewards, directors, officers, employees, and agents of any of them (either directly or indirectly).

BAN ON HORSE SLAUGHTER

Any owner or trainer who directly or indirectly participates in the transport or sale of a horse previously stabled at a CDI property to a slaughter facility, or to an auction that facilitates sales of horses for slaughter, shall permanently forfeit all stalling and racing privileges at any CDI property.

TURFWAY AFTERCARE PROGRAM (TAP)

TAP supports the Thoroughbred Aftercare Alliance, which distributes funds to accredited agencies.

1. The horsemen's bookkeeper will assess \$1 per starter from the owner's account, to be held in the TAP account. Owners may contact the horsemen's bookkeeper to opt out.
2. Turfway Park will contribute \$1 per starter to the TAP account.
3. Turfway will accept independent donations to the TAP fund.
4. Each year the balance of the fund will be sent to the Thoroughbred Aftercare Alliance for distribution to accredited Thoroughbred aftercare agencies.

EQUINE SAFETY CONCERNS

RACING AT TURFWAY PARK

NOTICE FOR HORSES SHIPPING TO TURFWAY: ARRIVAL

All horses shipping in to run at Turfway Park shall be on the grounds and in their proper receiving barn and assigned stall a minimum of four-and-one-half (4-1/2) hours prior to their race time.

All shipped-in horses will be assigned to a certain barn and stall by the stall superintendent or his personnel at the entrance gate.

NOTICE FOR HORSES SHIPPING TO TURFWAY: VETERINARIAN EXAMINATION

Trainers of shipped-in horses shall have a responsible person available to present the horse for examination when the veterinarian comes to the barn. Horses will have bandages off and are not to be placed in ice, tubs, leg freeze or other such paraphernalia until after the pre-race exam.

It should be further understood by all trainers that if an entered horse fails to receive a pre-race examination a late scratch may be necessary and the trainer shall be held responsible for this action.

HEALTH REQUIREMENTS: COGGINS, HEALTH CERTIFICATE & INOCULATION

GENERAL ENTRY REQUIREMENTS: All equines entering the backside of a Kentucky racetrack and sanctioned training facility shall be accompanied with a current negative EIA Test Certificate (aka Coggins) and be listed on a valid Certificate of Veterinary Inspection (CVI) issued by a USDA accredited veterinarian familiar with the horse and the environment from which it originated. The examination and issuance of the CVI must be completed during the 72 hours prior to the animal's arrival. Each horse entering the backside must be vaccinated against Equine Herpes virus Type 1 (EHV-1) by or under supervision of a licensed veterinarian a minimum of 14 days and no more than 120 days prior to entering the stable area. The inoculation should be recorded on the CVI by the issuing veterinarian and include the name of the product administered and date of inoculation. Once a horse receives the initial EHV-1 vaccination, revaccination should occur every 120 days. Please note the minimum 14-day vaccination applies only to horses that have not been vaccinated for EHV-1 during the preceding 120 days.

PLEASE NOTE: Health requirements for horses entering the grounds are subject to change without advance notice.

EARLY CANCELLATIONS

Trainers shipping to Turfway Park before 8:00 am during adverse weather/road conditions may contact the Stable Gate (859-647-4883) to confirm early cancellations. After 8:00 am, please contact the Racing Office.

TURFWAY PARK DATE PREFERENCE SYSTEM

Foal certificates are not required to be on file in the Racing Office to enter or start at Turfway Park; however, foal certificates must be on file to obtain and retain a preference date.

Each days overnight will list the dates of horses in the body and on the also-eligible list to enable trainers to see what dates are getting horses into over-filled races.

1. In over-filled races, preference will be given to horses in order of their assigned preference dates, earliest date first. Horses having identical dates will be chosen by lot, however, where entry and running dates are the same, the horse with the entry date will have preference.
2. All horses intended for racing at Turfway Park will be assigned a preference date. A horse can have only one date at any one time.
3. Horses with pending blood shall have no preference.
4. Covered Horses which have not started in more than 365 days and unraced Covered Horses which have not made a start prior to January 1 of their 4-year-old year shall retain their previously established date once removed from the Veterinarians list (providing the foal certificate is on file).

Dates will be of two types:

E-Date

This date will correspond to (a) the date on which a horse's foal papers/digital foal certificate and name card are submitted to the Identifier (their earliest date being the day when entries are first taken for the meet). The deadline to submit foal papers/digital foal certificates to receive a date on day of entry is 9:30 a.m. Eastern; (b) the day on which a horse is first entered if his papers are not on file with the Identifier. To qualify for the latter E-Date, a horse must have been excluded from a race that appears on the overnight or been entered in a condition book race which failed to fill through insufficient entries.

R-Date

This date will correspond to the day of a horse's most recent race at Turfway Park. An R-Date also will be assigned to a horse that scratches.

3. A horse retains his R-Date until he receives a newer R-Date. No horse with an established R-Date may receive an E-Date. A horse whose papers are removed from the Identifier's office will lose his date and must then re-establish a date to receive preference. A horse with an E-Date cannot receive a newer E-Date. Horses starting at another track will forfeit any date they may have at Turfway Park and must re-establish a preference date. Additionally, horses racing at Turfway Park without foal papers/digital foal certificate on site will not retain their R-Date.
4. Preference dates are good for any type of race or distance (other than maiden dates and stakes).
5. Maiden dates will be kept separately and will not have preference in winners races.
6. No E-Date will be assigned to the second choice of an un-split same-owner entry.

7. A horse placed on a list (Veterinarian, Steward, Starter or Paddock Judge) will lose its date and be assigned an R-Date corresponding to the day removed from the list.

8. Horses on the Also-Eligible List shall be permitted to draw into races and will be assigned post positions in the order of their dates, earliest dates first.

9. A horse which is a scheduled starter in a canceled race will not receive an R-Date for that race but will retain his previous date.

10. The draw of stake and handicap races is not subject to date preference.

11. Preference dates are transferred through change in ownership and changes in trainer only after the proper transfer procedures have been completed through the Stewards office and delivered to the Racing Secretary's office.

Entries will not close before 10:00 am ET daily. Entry closing dates are listed at the top of each page of conditions unless noted otherwise. Riders to be named at time of entry. Enter:

If there are any scratches in a race with also-eligibles, the also-eligible horses will be permitted to move into the race in the order listed on the overnight.

Eligible races can be readily recognized in the stakes and condition books by the Kentucky Thoroughbred Development Fund seal, which will appear next to each race in the stakes and condition books.

In accordance with KRS 230.400(5)(d), it is mandatory for a horse to be registered prior to time of entry to be eligible to participate in the distribution of Kentucky Thoroughbred Development Fund monies. Registration is only complete once the application is approved and payment has been received.

All horses of racing age that are both Kentucky-bred and sired by a Kentucky stallion which stood in Kentucky the entire breeding season the year the horse was conceived are eligible to be registered. Owners of horses of racing age are responsible for registering their horses. Stallion owners are responsible for registering their stallions.

Preference to start will be given in the following order: Graded/Group Stakes Winners on a Synthetic Surface (in order I-II-III), Graded/Group Stakes Winners (in order I-II-III); Graded/Group Stakes Placed (second and third in order I-II-III), Open Stakes Winners on a Synthetic Surface, Open Stakes Winners, then highest total earnings in 2023-2024. NOTE: Claiborne Farm Dollars / Credits are only eligible to be used for the mare that earned them, but they may transfer with the mare's ownership. Claiborne Farm Dollars / Credits expire at the end of the 2026 breeding season. Failure to draw into the race cancels all fees.

GENERAL: Entries to the race are received only upon the condition that the Applicant will comply with the rules and regulations governing thoroughbred horse races adopted by the Kentucky Horse Racing Commission (KHRC) and the rules and regulations of Turfway Park L.L.C. (the *Association) and will comply with and abide by any decision of the state racing officials and/or the officers of the Association regarding the interpretation and application of such rules and regulations. Applicant consents and agrees to all provisions of the Association's current application and/or agreement regarding the use of stall space, the terms of which are specifically incorporated herein by reference, and shall execute all such applications and/or agreements before bringing any horse upon the Association's grounds. In making this application to participate in thoroughbred racing, Applicant agrees and consents to the Association and/or its agents making an investigation of Applicant where by information may be requested from third parties as to character, general reputation, personal characteristics, mode of living, or such other information as may be relevant to the Applicant's integrity as a racing participant. The Association reserves the right to cancel any race, without notice, at any time prior to the actual running thereof, without liability except for the return of all fees as required by the rules of racing. The Association reserves the right to make all decisions regarding preferences and conditions and its decision shall be final. Nominations are received only with the understanding that the Association reserves the right, in its sole and absolute discretion to refuse, cancel or revoke any nomination, entry or stall application or the transfer thereof and reserves the right to deny the right to start in a race without notice to the Applicant and for any reason, including but not limited to the Applicant's failure to fully perform or abide by all provisions and conditions thereof.

Release, Waiver and Indemnification: All Kentucky Horse Racing Commission licensees, including but not limited to the host association, owners, trainers, jockeys, and grooms (*licensees*), participating in stabling, racing, training, and related activities at the Association recognize that hazards and risks inherent in such activities may cause the injury or death of horses. Therefore, in consideration of participating in stabling, racing, training and related activities at the Association, all licensees assume the risks of, and release, hold harmless and covenant not to sue all other licensees so participating for: (i) Ordinary negligence which uses or contributes to loss, loss of use, injury or damage to horses while on the premises of the Association; and (ii) Ordinary negligence which causes or contributes to personal injury or property damage including but not limited to loss, loss of use, injury or damage to horses arising from the use of grass fields or gallops owned or controlled by the Association, whether arising from alleged acts or omissions of a licensee and its agents or employees, the condition of the premises of the Association or any other cause. Except as provided above, all licensees participating in racing, training, and related activities at the Association shall be responsible for their own acts and omissions and those of their agents, employees to the same extent as provided by law. The foregoing provisions shall be construed in a manner consistent with the limitations set forth herein to be as broad and inclusive as permitted by the laws of the Commonwealth of Kentucky and the KHRC regulations and shall be binding upon Applicant, as successors and/or assignees. The maintenance by Association of insurance shall not affect the terms or interpretation of this Agreement. For purposes of this agreement, Association shall mean and include Association and its officers, directors, agents, employees, contractors, servants, and licensees. In the event of any inconsistency between these provisions and KHRC regulations, the KHRC regulations shall control. Further, these provisions shall be deemed to be amended to the extent of, and to be in compliance with any amendment to the KHRC regulations. Responsibility for the maintenance of general liability and horse

mortality insurance to cover the risks outlined above vests with the applicant. Consultation with a competent insurance advisor is strongly recommended. Failure to maintain adequate insurance may subject the Applicant to the risks outlined above.

Reservation of Rights: As the organizer, horse and sponsor of thoroughbred horse races, the Association hereby reserves unto itself, its agent, assigns and licensees, the sole and exclusive right to produce, exhibit, sell, license, transfer or transmit in any manner still or motion pictures, radio and television broadcasts, or any other media transmission, now known or hereafter developed, of all events which occur on the Associations property, including without limitation, all activities occurring before, during and after thoroughbred horse races; and the sole and exclusive right to utilize the race and the results thereof, all for any purpose or use as the Association shall determine (hereinafter referred to as the "Host Rights"). The acceptance of stall accommodations, the submission of a nomination or making of any entry in any race shall mean that the Applicant consents to the above reservation of the Host Rights and consents to be photographed or to otherwise be a subject of still or moving pictures, radio, or television programs, without remuneration. The Applicant agrees that he has not and will not execute any documents or take any other action which purports to assign or otherwise transfer any interest in the Host Rights or assert any claim, demand or cause of action against the Association which is inconsistent with the full and exclusive exercise by the Association of its Host Rights.

Interstate Wagering: In consideration of the Associations agreement to provide a portion of revenues received from interstate wagering to purses for races run at the Associations facility during the 2024 racing season (the "Races"), the Applicant hereby joins with all other applicants to form a group consisting of all applicants participating in each of the races, which group is hereby authorized and directed to consent to, and the applicant hereby individually consents to, allow the association to contract with any domestic or foreign license wagering entity for the purpose of accepting wagers on the Races pursuant to the interstate Horseracing Act of 1978, 15 U.S.C.301 et seq. The Racing Secretary of the Association is authorized to execute any documents necessary to evidence such individual and group consents. The applicant warrants that no third party organization has or will be given the right or authority to assert any claim, demand or cause of action inconsistent with such consent.

Definition of Applicant: As used herein, the "Applicant" shall mean and include the nominating owner(s) and the owners agents, trainers, jockeys, employees, invitees, and their agents, employees and invitees and the heirs, administrators, representatives, next of kin and assigns of each of them. The nominating owner covenants that his agents, trainers, jockeys, employees and invitees have agreed for themselves and their agents, employees, and invitees to the foregoing conditions and further agrees that he will deliver their written consent and agreement to such conditions upon request of the Association. The owner and trainer shall, jointly and severally, indemnify and hold the Association harmless from and against any claim or cause of action (including any expense incurred in connection therewith, including reasonable attorney's and other fees) that may be asserted by or on behalf of any of the foregoing persons which is inconsistent with the release, waiver and indemnification provisions set forth in the foregoing paragraph.
